註一:身分證明 Documents to prove your identity:

- 1. 個人:國民身分證或軍人身分證或僑民居留證明。Individual: Identification Card, military certificate or Alien Residence Certificate
- 2. 公司、行號:營利事業登記證或核准之公文(公司含登記表)。若為影本,需另附最近一期繳納營業稅證明文件影本。Corporate: the Certificate of Business Registration. If it's a copy, you are required the latest copy of business tax certificate.
- 3. 機關團體:檢附機關團體證明文件及財稅機關編發統一編號證明。Organization/groups: certificate of establishment and the tax registration code issued by the taxation authority.
- 4. 委託他人代辦車輛過戶時,需再附雙方車主有效之駕駛執照或全民健康保險卡或護照。 If you commission someone to do transferring, you are required the effective driving license, national health insurance card, or passport of both owners .

註二:車輛來歷證明 Documents to prove the vehicle

- 1. 進口車檢附海關進口與貨物稅完(免)稅證明書、出廠證明、統一發票。Imported vehicles: clearance certificates for custom duties and goods tax(tax exemption certificate), the manufacturer certificate, an invoice.
- 2. 國產車檢附出廠與貨物稅完(免)稅照證、統一發票。locally manufactured vehicles: clearance certificates for custom duties and goods tax(tax exemption certificate), an invoice.

註三:改加裝設備文件 Documents for alternation of equipments

改加裝設備文件係指安全審驗證明、汽車車廠改裝證明及營利事業登記證或工廠登記證影本。Vehicle safety testing certificate, factory modification certificate, certificate of profit seeking enterprise, or the copy of certificate

其他注意事項: Attentions

- 1. 汽車出廠 10 年以上、機車出廠 5 年以上,過戶應先經臨時檢驗合格。
 - The vehicle should pass the on-site inspection before transferring (the age of the vehicle is over 10 years for the car and over 5 years for the motorcycle)
- 2. 車輛顏色、地址及車主名稱變更登記免附貨物稅完(免)稅證明、統一發票及改加裝設備文件。
- Alteration of automobiles colors, the owner's name and the address is not required the duty payment (tax exemption) certificate, an invoice and documents for alternation of equipments.
- 3. 汽、機車號牌遺失或損壞,申請換牌前均需經檢驗合格(實車查核)後始得辦理(汽車號牌遺失一面者,另一面須繳回)。 The replacement for lost or damaged license plates is required the inspection. (if only one license plate is lost, the remaining one should be returned to authorities.)
- 4. 繳、註、吊銷之車輛,需重新檢驗合格後始得請領牌照。 For issuing a new plate, vehicle which is revoked, scrapped, or cancelled is required inspection.
- 5. 車輛停駛期間最長以1年為限,逾限者註銷牌照。
 - The period of suspension is no longer than one year. If the period is greater than one year, the plates will be cancelled.
- 6. 停駛超過3個月或已逾定檢日期之車輛,復駛前應先繳費檢驗合格後始得辦理。
 - For resumption applications, the vehicle which is overdue the periodic inspection or remains suspended for over 3 months should charge the fee and pass the inspection.
- 7. 拒不過戶註銷僅限於自用小型車及機車方可辦理。
- ${\it Cancellation \ of \ un-transferred \ vehicles \ is \ limited \ for \ small \ cars \ and \ motorcycles.}$
- 8. 小型汽車定檢,得免附牌照登記書車主聯。
 - The small car's inspection is not required new license plate registration form.
